

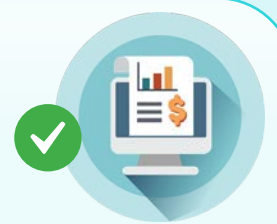
# Receiving eInvoices: How to get ready.



**Getting set up to receive eInvoices is easy and free for most small businesses. Most accounting and invoicing software, including the likes of Xero, MYOB and Reckon, provide or are currently developing free or low-cost eInvoicing capability.**

## Step 1: Check your accounting or billing software.

The first thing you need is eInvoicing capable accounting or invoicing software. You can check if your software is capable by checking the website of your software provider, the growing [providers list](#) on our website, or by asking your accountant.



## Step 2: Get registered.

Your next step, is getting registered to receive eInvoices. This process varies from software to software - but in most cases, it's easy and free. Follow the instructions given by your software provider or check with your accountant.



## Step 3: Let your suppliers know.

Once you're registered, start letting your suppliers know that you'd prefer to receive eInvoices - not a PDF. They'll need your New Zealand Business Number (NZBN) to do this - and they'll need to be eInvoicing capable themselves.

There's a [supplier communications toolkit](#) online, that shows you how to point your suppliers in the right direction - so that they, and you, can get the benefits.



## At that point, you're ready to go!

When you start getting eInvoices, the layout might be a bit different to a traditional PDF invoice - depending on your software.

But rest assured, it's a genuine invoice that meets the IRD's requirements.
